The past twelve months have been a period of significant challenges in solidifying the Namibian Bar Association ("NBA") as a small but conspicuous institution within the Namibian legal fraternity.

Foundational Year

The establishment of the NBA was a momentous occasion, driven by the collective desire of a few visionaries to strengthen the profession and better the delivery of advocacy services to the Namibian public. Key Achievements
